Terms & Conditions

By signing you accept the following terms and conditions.

1 Minimum spend

For events from 9 guests a minimum spend on food and drink is agreed. The rate of the period chosen on page 1 applies — EUR 59 per person at lunchtime (11 am – 5 pm), EUR 79 per person in the evening (from 5 pm) or EUR 99 per person in the evening during peak season, each incl. the applicable VAT; the agreed start of the event is decisive. For a regular reservation it is based on the number of guests bindingly registered; for the exclusive booking of an area on the total number of seats of the chosen area — regardless of the actual number of guests. It is credited in full against consumption; if it is not reached, the difference is payable. The lunch rate applies all year; the peak-season rate applies only in the evening on public holidays, during peak season from 1 October to 30 December and at major Frankfurt trade fairs.

2 Menu selection from 15 guests

From 15 guests à la carte ordering is not possible; the selection is agreed in advance. Per course up to two dishes from the current menu may be chosen, plus one vegetarian dish. Please send us your selection in text form at least 72 hours before the event. If it does not reach us in time or not in this form, we set a grace period of 24 hours; only after this has expired without result are we entitled to withdraw from the contract. In the event of withdrawal the claims under clause 4 apply accordingly.

3 Cancellation and number of guests

Up to 72 hours before the start you may cancel free of charge or reduce the number of guests. After that please notify us of any change immediately in text form; for cancelled guests or no-shows the following clause applies.

4 No-show fee

If the group does not arrive, or not in full, without having notified us in text form at least 72 hours before the start, we are entitled to a flat no-show fee per missing guest — EUR 47, 63 or 79 per person, being the minimum spend of the booked period less 20 % saved costs, rounded down in your favour (tiers see page 1). The deduction reflects saved costs, in particular the cost of goods. Revenue actually earned from the freed-up seats is credited. No double charging: for guests for whom a no-show fee applies, the minimum spend is reduced accordingly; where, for an exclusive booking, the minimum spend is already based on the seats of the area (clause 1), no no-show fee applies for those seats. You are free to prove that no loss or a substantially lower loss occurred; we are free to prove a higher loss — for instance for goods procured specifically for the group. Any amount collected in excess we refund without delay. The no-show fee is not payment for a service and therefore contains no VAT.

5 Security by credit card

As security you provide the card details stated on page 1. A charge is made solely up to the amount of the no-show fee under clause 4 (non-arrival) — not at booking and not for the bill of the event itself. We keep the form under lock and key and render the card number illegible after your event or after settlement.

6 Late arrival

As soon as it becomes foreseeable that you will arrive more than 30 minutes after the agreed time, please inform us immediately. Otherwise, after a waiting period of 45 minutes — and only after an attempted call to the mobile number provided — we are entitled to release the seats reserved for you for general sale; the kitchen has also purchased, planned and held capacity for your group. If you arrive only after the seats have actually been reassigned and we have no other seats free, this counts as non-arrival within the meaning of clause 4 (no-show fee EUR 47, 63 or 79); revenue earned from the reassigned seats is credited.

7 Billing

Separate billing of the food and drink consumed by each participant is excluded. One total invoice is issued for the group, to be settled in full on site immediately at the end of the event — for card payment with a physically presented card. The credit card provided per page 1 is not charged for this; it serves solely as security in case of non-arrival (clause 4). Differences between minimum spend and actual spend are shown separately on the invoice.

8 Service charge

For groups we charge a service charge of 10 % on the final invoice total. It is added to the invoice amount and does not count towards the minimum spend; it is also levied on any difference under clause 7, but not on a no-show fee under clause 4. The service charge is shown separately on the invoice.

9 Additional services

On the attached extras sheet (page 3) you may request wishes. These are not part of this contract; you receive a separate quotation for them. Bespoke items (e.g. table decoration, cakes, printed menu cards) are quoted in advance, ordered only against prepayment and are not part of the minimum spend.

10 Opening beyond 10:30 pm

Kitchen until 9:00 pm, house until 10:30 pm. At your express request and with our consent we stay open longer; we charge EUR 300 per hour begun. The kitchen is excluded from any extension — it closes in any case at 9:00 pm. After that we serve cold and hot drinks as well as baked goods from our bakery counter and pre-ordered cakes.
